

Uncontrolled wildfires in sensitive areas like Dartmoor can cause long-lasting damage to wildlife and have a significant impact on the landscape. Wildfires also put livestock and members of the public at risk.

Wildfires are a serious problem for the fire service

Wildfires under the right conditions can be extremely dangerous with flame lengths exceeding 1.5 metres and fast moving. Wind speed, wind direction, humidity, temperature, all these variables have an impact in terms of wildfire.

Most are started by human actions such as: disposable barbecues discarded cigarettes and campfires.

What can we do to prevent wildfires?

We ask people not to use barbecues, to take extreme care when disposing of cigarettes and matches and to take all litter home when they leave. Great care should also be taken with camping stoves and fuel which are always best placed on flat stones wherever possible.



What to do if there is a fire

Keep calm. Call **999** and ask for the Fire and Rescue Service and give your exact location.

Providing a six-figure map reference or What3words.

Make sure you download the What3words app on your phone – this can help the fire service pinpoint your exact location in the event of a fire.

Distance yourself from the fire

Contact your Team leader (during training) explain the situation and where you are heading.

Team Leader to contact Fire Control on 03333990014 or 999 to confirm that the team are distancing themselves from the fire and heading towards.

2. Head of Establishment (HoE). *The HoE ... is responsible, on behalf of the employer, for the safety of their participants in training, although this may be delegated to a designated Team Manager (completed online via TM Dashboard).*

The HoE must assure the Director Ten Tors that all the team management are competent and suitable for the role to which they are assigned.

By sponsoring an entry the HoE accepts responsibility for all participants' behaviour in training ... this includes individuals who are not members of their own establishment.

HoE Assurance to be completed via the dashboard **before** you can start training.

3. Team Manager. The **TM**, appointed by the HoE, is responsible for all aspects of their Team's training.

With the agreement of the HoE, the TM may delegate training and other duties to competent and qualified Training Event Leaders, deputies and assistants.

*Prior to the start of a Challenge, the **TM is required to assure the Director that all participants ... are sufficiently trained [and] physically prepared... to complete [their Challenge] unaided even in adverse conditions.***

22. [General] Requirement. *The Challenges are demanding expeditions. Thorough preparation and training are essential to complete the Challenges safely. The HoE is responsible, through their TM, for the conduct of training. The MOD accepts no responsibility for safety in training.*

24. Incidents. *The Ten Tors Secretary, or at weekends the Ten Tors Duty Officer, is to be informed **within 48 hours** of any incident in training that:*

- a. Involves the **emergency services.***
- b. Results in **hospital treatment.***
- c. May result in **media coverage.***
- d. May lead to **complaint from a 3rd party.***

16. Individual training requirement. *Before the Event participants must complete a structured and progressive programme of training which includes as a minimum:*

- a. Minimum of 4 days of training on Dartmoor.*
- b. 2 nights of wild camping on Dartmoor.*
- c. From 01 Feb no more than 4 days on North Moor*
- d. Experience of walking in an unsupervised group.*

17. Team training requirement. *In addition to the above, Teams must:*

- a. Be sufficiently trained, physically prepared and suitably equipped to enable the team to operate safely on their own and complete the Challenge unaided even in adverse conditions.*
- b. Train as a team on at least one expedition noting that best practice would be to conduct regular training as a defined team. **Last minute composite teams are not permitted.***

General

- The [Dartmoor National Park \(DNP\) Byelaws](#) are to be obeyed at all times.
- The TM is to ensure that the Ten Tors Secretary, or (if over a weekend from 11 Oct to the Event) the TTDO, is informed within 24 hours of any incident as detailed in the Rules.
- Establishment Codes are to be displayed on two A4 panels which are easily visible to ground observers.
- The Rules for Participants should be explained as part of an establishment's preparation phase training.

Planning

- TMs are to minimise the environmental impact of training, for instance by selecting locations other than the tops of tors as checkpoints or making maximum use of Public Rights of Way (PROWs) and existing paths. Consider training on areas other than Dartmoor.
- All maps must show Out Of Bounds (OOB) and rare bird nesting areas (RBNA) as detailed in the Annex A to the Rules.
- During the training period, other areas may be designated as OOB: ensure you check the Ten Tors website when planning training.
- Ensure groups only used permitted paths near Standon Farm during training.
- From 11 Oct 25 onwards:**
 - TMs are to inform the Organisers by 0800 Wednesday each week of training for the coming weekend using the TM's dashboard; this is to assist with training compliance and environmental monitoring. Although training is not checked or monitored for safety purposes a list of planned training is provided to the emergency services and Dartmoor National Park Authority (DNPA) to assist in the event of incident.
- From 1 Feb 26 onwards:**
 - Walking groups are limited within the North Moor (the area North of the Tavistock – Two Bridges – Moretonhampstead road and west of the 68 easting) to no more than 4 days training for a maximum of 12 + 2 adults per allocated team eg. establishments with 3 teams participating are not permitted more than 42 walkers.
- There is to be **no training** on Dartmoor over the Easter weekend (**03 Apr – 06 Apr 26**).
- Base camps are not permitted on the open moor. TMs must arrange for these to be located at established campsites or, with the landowner's permission, on private land. Details of landowners prepared to permit camping are on the [Enjoy Dartmoor](#), [Visit Dartmoor](#) and [Ten Tors](#) websites.

Vehicles

- Vehicles are to have the establishment's Code clearly displayed on the dashboard.
- All non-metalled roads (including the Okehampton Range Loop Road) are OOB to vehicles unless permission is given by the TTDO or HQ DARTA.
- Off-road driving is not permitted.

- Unless parking off the road with the permission of the landowner, only designated public car parks are to be used. Be considerate of others in public car parks and leave at least half of the area for public parking.
- Thoroughfares and gateways are not to be obstructed.
- The National Park Byelaws prohibit overnight sleeping in vehicles in car parks or on roadsides.

Understand property rights

- All of Dartmoor is owned by somebody.
- Enclosed land is not to be used without the permission of the landowner unless it is a PROW or Countryside and Right of Way public access land.
- Commons and Access Land, as shown on Annex A, may be used for walking.
- Backpack camping is only permitted in the areas shown on the [DNPA website](#).

Respect the Moor and its other users

- Tread lightly. Leave no trace. Give nature space.
- Engage with other walkers and farmers, who you meet.
- Do not enter OOB areas.
- If a track is worn do not walk alongside it as this will spread the erosion.
- Do not climb over walls or field boundaries - use gates, stiles or constructed gaps.
- Close gates irrespective of how you found them.
- Respect all ancient monuments and ruins.
- Do not disturb stones from moorland, dry stone walls or old buildings.
- Do not pollute or obstruct streams rivers & leats – they may be somebody's water supply.
- Take all litter home.
- Bury poo and toilet paper under at least 15cm of turf.
- Do not disrupt or cause a hazard to traffic.

Prevent wildfires

- Wildfires can be devastating; do not light open fires or take naked flames near flammable areas.
- Use cooking stoves carefully.
- Farmers are permitted to conduct controlled burning to manage vegetation between 1 Oct and 31 Mar; these types of fire will be under close supervision and over relatively small areas.
- Report all uncontrolled or suspicious fires to the Fire Service on 999 immediately.

Protect plants and animals

- Avoid disturbing plants, wildlife, and livestock.
- Rare Bird Nesting Areas (RBNAs) must not be entered during the period 1 Mar – 31 Jul except in emergency.
- Dogs must not be allowed to disturb animals.
- Do not feed or touch ponies or attract them to the road.
- Leave young or distressed animals alone.
- Report animals in distress or stray dogs to the Dartmoor Livestock Protection Officer on 07873 587561.

Camping

- Backpack camping locations are to be at least 100m from any building, road, or other backpack camping location and are to be within areas permitted on the [DNPA website](#).
- Do not backpack camp in sight of a road or building.

Environmental Control Monitors

- If you are stopped by an adult remember to ask them for their ID card. Only take advice from someone that shows you a Ten Tors ECM card.

In the case of an emergency:

- Stop. Make sure all the group are together.
- Follow your first aid training: DRS ABC
- Contact your Off Moor Controller or Training Leader and provide them with this information:
 - Who is injured.
 - What the injury is.
 - Your location – grid reference.
- Make yourselves visible.
- Use a whistle and/or torch to attract help.
- Keep a light on in your tent, this aids the rescuers in locating you.
- Listen for horns or whistles blowing and respond loudly.

WHY DO WE HAVE ENVIRONMENTAL COMPLIANCE MONITORS?



WHY DO WE HAVE TO COMPLY?

The Ten Tors Challenges only exist with the agreement and support of Dartmoor stakeholders.

The ECM team provide assurance that those venturing onto the moor under the guise of Ten Tors meet a set of standards, our rules.

Everyone should want to uphold this promise.

The Rules For Training (Green Card) should be common sense for regular moorland visitors.

WHY IS COMPLIANCE FALLING?

The last year saw the lowest level of compliance since monitoring began.

This is a serious concern as we must uphold our commitments to local stakeholders.

We have reviewed our reports and data from both the training phase and the event, and a few patterns seem to be clear.

COMMON EXCUSES

“We are doing this next week”

“It's our first time on the moor”

“We haven't covered this yet”.

“As a TM I don't get it, it's not difficult to be compliant unless you choose to ignore the advice, instructions and directives.”

A good Team Manager will have completed Care and Respect Training before going to Dartmoor.

NEW TEAM MANAGERS

The role of Team Manager is time consuming and onerous. To learn the ins, outs and foibles of Ten Tors takes a couple of years.

We understand this, we walk that walk too.

**There is help out there, don't be afraid to ask for advice.
We want you and your teams to be successful.**

EXPERIENCED TEAM MANAGERS

Ten Tors changes each year.

Rules change.

Routes change.

RBNA areas change.

For experienced TMs to fall foul of the rules is disappointing.

Are TMs getting the information from the TMB ?

WHAT SHOULD A MEETING WITH AN ECM BE LIKE?

- An ECM should approach and identify themselves
- ECMs are likely to ask where the group has been and where it's heading.
 - ask to see maps with RBNAs correctly marked on them.
 - ask about Green Cards: are contents known?
 - check that the group is properly ID'd with Establishment numbers on two rucksacks
 - Green card is completed correctly and that the team know their emergency procedures.

WHAT SHOULD AN IDENTIFICATION PANEL LOOK LIKE?

A **minimum** of two identification panels are to be displayed at all times.



2025 COMPLIANCE DATA

- 31 ECMs covered all weekends from TMB to TTC
- We spent a total of 255 days out, up from 165, and 137 in 2024
- An average ECM day is 7-9 hours, most are part of an establishment's training team
- We met a total of 466 groups, up from 315, 309 in 2024
- 68% of groups were compliant, down from 85%, 86% in 2024
- 91 establishments did not meet minimum expectations, about 48% of all establishments.

Around Postbridge – road walking, Archerton, OOB
field crossings

CRITICAL INFORMATION TO TAKE AWAY

- Rules For Training On Dartmoor start **NOW**
- RBNA **MUST** be on maps from...**1st February**
- **Red** river sections are OOB throughout training
- Knowledge of the rules needs to be embedded **BEFORE** visiting Dartmoor

Extreme Lower Limit versus Comfort

Comfort rating indicates the temperature at which a cold sleeper might feel comfortable. This is the temperature rating brands use on women's bags.

Lower limit rating (which is always lower than the comfort rating) indicates the temperature at which a warm sleeper might still feel comfortable. This is the temperature rating brands use on men's bags.

ISO 23537 or EN13537 Compliant to -2 degrees C

Temperature ratings are estimates, not gospel

Although Sleeping Bags are generally tested to standards in a lab, it can't account for variations like differences in people's clothing and gear (i.e. sleeping pads), differences in body types (warm and cold sleepers), changing weather conditions, differences in food people eat and more.

You are responsible for ensuring your participants are comfortable throughout the training and Event. If in doubt advise your participants to obtain a sleeping bag that exceed the limit not meets it.

TEN TORS 2026 PINK CARD RULES FOR PARTICIPANTS

Cold Injury (Hypothermia).

- Extreme cold, violent shivering, stiffness, tiredness, increased heart rate and irrational behaviour.
- Stop, get under cover, replace wet clothing, rewarm slowly, add extra layers, give warm sweet drink or energy food; do not try to warm by rubbing limbs.

Non-freezing cold injury.

- Hands and feet suffer pins and needles and / or feel numb.
- Dry hands and feet, change socks and gloves, use foot powder, wriggle limbs and exercise.

Freezing cold injury.

- Cold, painful, tingling followed by numbness (including if moved) and mottled white and pink skin.
- Get into shelter; do not re-warm.

Heat illness (Hyperthermia).

- Nausea, vomiting, cramps, disturbed vision, agitation, dizziness and confusion.
- Stop, lie casualty in the shade, remove appropriate layers of clothing, and apply wet cloth to limbs and head. If conscious give water and elevate feet; if unconscious place in the recovery position.

In all cases of climatic injury request assistance immediately and be aware that others are also likely to be at risk.

N.B. Water self-replenishment and purification is the team's responsibility.



TEN TORS 2026 ORANGE CARD RULES FOR TEAM STAFF

Team Managers (TMs) and Staff are responsible for:

- The **conduct and wellbeing of participants**:
 - From arrival at Okehampton Camp until the start of the Challenge. From handover at the Finish or withdrawal system until departure from Okehampton Camp.
- The **conduct and safety** of all involved with a Team including **supporters**.
- Ensuring that all those in the campsites, including visitors, are properly briefed. Visitors entering will receive basic safety information in the brochure issued to all drivers in the carparks.
- Issuing the Notice to Parents and Guardians and **acting as the link between them and the Organisers**.

Fire.

- Keep all designated routes in campsites clear and make sure that everyone knows where they are.
- Identify walkways to the designated main routes and liaise with neighbours to keep them clear.

- St John Ambulance have mobile medical staff across Okehampton Camp during the Event that can be tasked by calling mobile number: (TBC two weeks from Event date)
- First Aid Posts are established across Okehampton Camp.

Vehicles.

- Drivers are to follow the directions of Traffic Marshals, use the **one-way circuit** and comply with the traffic circuit speed limit of **15 mph**.
- Unloading and loading is only permitted in designated areas; **Jubilee Challenge vehicles will only be allowed to enter the campsite in exceptional circumstances.**
- Vehicles are to be **parked in designated parking areas** as directed. Vehicles that are illegally parked or causing an obstruction may be towed away or receive a fixed penalty notice from the Police.
- There will be **NO vehicle exit** from Okehampton Camp on **Sat 0600-0700hrs**. All traffic leaving Camp will be directed onto the **A30 westbound slip road from 0500 Saturday until endex.**
- Camper vans are only allowed in designated parts of the carpark; caravans are not permitted.
- **Please inform spectators – first aid and likely traffic situation**

TEN TORS 2026 ORANGE CARD RULES FOR TEAM STAFF

Environmental Protection.

- Use the litter and toilet facilities provided and report any problems immediately.
- Showers are available for **adult Team Staff only** on **Sat 1000 – 1400hrs** in Building 91.
- Do not climb over fences or rest kit on them – use the gateways provided.

General safety.

- Teams or advance parties are not permitted to enter the campsites before **Thu 0630hrs**. **Participants are not allowed to sleep within the campsite until 0900hrs on Fri.**
- Establishments are to set up their own base within a campsite at Okehampton Camp; water, toilets, recycling and some catering is available, but otherwise Establishments must be self-sufficient. Please be considerate of others when choosing where to camp.
- Dogs must be kept on a lead, may only transit the campsite, and must not stay overnight in carparks.
- **Flying drones is strictly forbidden** due to the serious safety risks they pose to helicopters. **Please tell spectators.**
- TMs are to ensure that **alcohol** is consumed in a responsible manner; **one member of staff must be able to take Safeguarding responsibility for their team at any point. Use What 3 Words for location within campsite.**
- Keep campsite noise to a minimum from Fri 2200 – Sat 0500hrs and Sat 2200 – Sun 0700hrs.

Registration.

- Route allocation will be published on the TT website at 0900hrs on the Tue before the Event.
- TM + 1 Participant per team, report to Registration on Fri **0900 – 1700hrs to:**
 - Confirm that team composition and critical information is correctly recorded.
 - Complete and hand in the Campsite record (**What3Words for TT26**).
 - Media consent forms (**online via the dashboard**).
 - Collect wristbands, x2 rubbish bags, Safety Beacon, opaque bag for mobile phone and a TT Map (if required).
 - Add the river state to Control Cards.
 - Receive Participant Beacon training



Post Registration.

- Individuals are to be securely fitted with their personal ID wrist bands.
- TMs are to check maps are marked with **all** staffed locations supporting the JC, GC or TTC and all the detail contained in Annex A and Annex B to the Rules.
- TMs are to check teams' proposed routes for suitability and compliance with the rules

TEN TORS 2026 ORANGE CARD RULES FOR TEAM STAFF

Safeguarding.

- The TM or Deputy TM member with photo ID, is to accompany participants to their start point by 0645 / 0715hrs.
- Either the TM or Deputy TM is to be contactable in Okehampton Camp and able to accept safeguarding responsibility at all times during the Event until all participants have been signed back.
- Participants (whether VW or DW, casualties or successful finishers) will only be signed back to the TM or Deputy TM with appropriate photo ID. In the event of hospitalisation responsibility will be handed over to the hospital and the TM or Deputy TM will be informed.
- If a participant has not been returned to the TM by Sat 1800 (JC) / Sun 1700hrs (TTC/GC) they must report this to the Withdrawal Coordination Centre to ascertain their location.

Conduct.

- Supporters and Staff must not interfere with the smooth running of the Challenge or compromise the unsupported aspect except within 500m of the start and finish where they may encourage and enthuse.

Post event.

- TMs are to inform the Organisers of any incident that occurs as a result of Ten Tors as detailed in the Rules.

Additional Rules for the Ten Tors Challenge.

Extraction Contingency.

To support contingency plans for extracting large numbers of participants off the moor from Sat 0700hrs until the Establishment's final departure from Okehampton Camp, any Establishment with more than one team in the TTC is required to:

- Designate a road legal minibus which is to:
 - Be insured to transport participants from any Establishment.
 - Remain parked as directed in Okehampton Camp.
- Ensure a qualified and DBS-checked adult is fit and available to drive at one hour's notice.
- Plan for both to be deployed across Dartmoor in support of the Event at the cost of the Establishment.

TMs Update. The Team Managers' Update on Sat 1800hrs will include critical safety information for the following day and thus attendance from at least one member of Staff per Team is mandatory.





Safeguarding is Everyone's Responsibility

- **Policy.** Available on TT Website, it essential that this is read and understood.
- **Roles.** TT provide personnel from Army Cadet Safeguarding Hub to deliver event Safeguarding leadership, BUT it is essential that TMs partner.
- **TMs.** Must ensure adults are trained, prepared, deploy and able to support TT safeguarding team throughout and are able to take safeguarding lead following weekend.
- **Reporting.** Safeguarding Reports can be submitted via form in TT Safeguarding Policy, BUT TT Safeguarding leads will respond to any issues identified through TT Ops Room. Then link at earliest opportunity with relevant team's Safeguarding Lead.

Safeguarding is Everyone's Responsibility

- **Safeguarding Timeline.** TMs lead safeguarding responsibility until start day. Military Safeguarding team take leadership during event BUT must be supported by TMs.
- **Information Sharing/Communication.** It is essential that proactive information sharing occurs. TT Safeguarding team should be made aware of any potential safeguarding issues re participants prior to and during event.
- **Post Event.** TT Safeguarding Team will report incidents to participant organisations, Designated Safeguarding Leads (DSL) and if required statutory authorities.




- This may be over one year or multiple years and should consider what the individual would be expected to do, and what they have delivered.
