

Entries for the Ten Tors Challenge and Jubilee Challenge 2019

Entries for the Ten Tors Challenge and Jubilee Challenge must be submitted by Team Managers between Thur 30 Aug and 2359 hours Tue 25 Sep.

Applying. The process is:

- Open the Ten Tors Website, click on Your Dashboard under the respective Challenge tab.
- For Team Managers that have applied before: Use your last year's log in details. You then only have to amend the information already recorded. If you have forgotten your password, use Reset your Password.
- For new Team Managers of Establishments that entered in previous years: Use the log in details of your predecessor, change the details of the Team Manager to yourself and then set a new password.
- For new Establishments: The Team Manager will be required to complete a full registration by clicking on the [Click here to register](#) link.
- Your check: Requests for entries and reserve places will be published on the website soon after they are received so that you can check progress. Queries will be published on the website for Team Manager's action.

Guidance on completing your entry:

- The TT rules are currently being rewritten, however the eligibility conditions will remain the unchanged. Therefore, please check Ten Tors Rules 1 – 17 to ensure that your entries are compliant. The form for the Head of Establishment's signed agreement to the entry and conditions will be published on the Website later and is to be handed in at the Team Manager's briefing Sat 13 Oct 18.
- Establishment Name: Maximum of 30 characters. Use lower case with, where applicable, the first letter of each word in capitals. To assist indexing do not include 'The' as first word.
- Qualifications: The minimum qualifications are in the Responsibilities and Competence section of the Guidance Booklet are [here](#) . The sum of the qualified Team Managers and Group Leaders must be equal to or exceed the number of teams applied for. Neither duplicating the Team Manager as a Group Leader, nor use a person already 'claimed' by another Establishment is permissible.
- Briefing Attendance: Please use the drop downs to show attendance at the briefing for 2016 or 2017 TT briefings or your intention to attend the briefing on 13 Oct 2018 for TT19.
- County: Use lower case with first letter capitalised. Torbay and Plymouth are in the County of Devon. The County of Bristol and North-east Somerset should be entered as 'BANES'. Please abbreviate Hampshire as 'Hants'.
- Scout Qualifications: Scout Leaders must have the required POR for walking and camping. Other Establishments may not use scouting qualifications.

Selection. The Selectors will meet to select individuals and teams on 27 Sep with the intention of publishing their conclusions late on Fri 28 Sep.
